# 2. TIN description

The competent Tax Authority issues TINs which are however not reported on official documents of identification. The TINs shall be used for a unique definition and correlation of data in the records kept by the Financial Administration of the Republic of Slovenia. The TINs are used for all taxes.

### 3. Where to find TINs?

TINs are not reported on official documents of identification, but they can be found on:

#### 3.1. Certificate about the entry into the tax register

The Financial Administration of the Republic of Slovenia issues a certificate within 8 days after the entry into the tax register. The TIN is written on the following certificate.
